4. PUBLIC HEARING

4A. Rule-making hearing to repeal WAC 132M-136 and replace it with new WAC sections Title 132M-139 Use of College—Expressive Activities, and 132M-141 Rental of College Facilities.

At 8:34 a.m., Vice Chair Vincent opened the public hearing. He explained that this is the date for the public hearing on the adoption of the revision to rules held under the authority of RCW 28B.50.140. A Notice of Proposed Rule Making was filed with the Office of the Code Reviser on June 5, 2018 and published in Washington State Register #18-12-093. The purpose of the hearing is to receive public comment on the proposed rules. No comments were made. Vice Chair Vincent asked Linda Clark, Rules Coordinator, if any written comments had been received on the proposed rules. One comment was received on section 132M-141-130 Denial of Use suggesting the change of one word in the first sentence.

5. **RESOLUTION #76**:

Request Temporary Waiver for High School Graduation Requirements for Lower Columbia College's Career Education Options (CEO) students.

CEO Director Heidi Patrick explained that the state changed laws to increase high school graduation credits to 24 starting in 2019. Several local schools have asked for, and been granted, a waiver until 2020; therefore, LCC is requesting the same waiver be granted to our Career Education Options (CEO) program to delay implementation for graduating classes of 2019 and 2020.

That a request to the State Board for Education be made for a temporary waiver to delay implementation of the 24 credit high school graduation requirement for the Lower Columbia College Career Education Options educational recovery program effective with the graduating classes of 2019 and 2020."
