Purpose: Lower Columbia College must amend their chapter 132M-125 WAC to meet new federal regulations for Title IX of the Education Amendments of 1972 (Title IX) that specify how recipients of Federal financial assistance covered by Title IX, including postsecondary institutions, must respond to allegations of sexual harassment consistent with Title IX's prohibition against sex discrimination. These new regulations go into effect August 14, 2020.

EMERGENCY RULE

Under RCW 34.05.350 the agency for good cause finds:
