Purpose: This emergency rule is similar to the emergency rule adopted on 8/13/2020. The Colleges has filed a notice of intent to adopt the rule as a permanent rule on December 16, 2020, and is actively engaging in adopting the permanent rule. This emergency rule is for Lower Columbia College to amend their chapter 132M-125 WAC to meet new federal regulations for Title IX of the Education Amendments of 1972 (Title IX) that specify how recipients of Federal financial assistance covered by Title IX, including postsecondary institutions, must respond to allegations of sexual harassment consistent with Title IX's prohibition against sex discrimination. These new regulations went into effect August 14, 2020.

EMERGENCY RULE
