



## 2022-23 PARENT PLUS LOAN WORKSHEET

PLUS loans are federal loans that parents of dependent undergraduate students can use to help pay education expenses. To receive a PLUS loan, you must be the parent (biological, adoptive, or in some cases, stepparent) of a dependent undergraduate student.

Steps to Process a Parent PLUS Loan:

1. Students are required to file a 2022–23 FAFSA. If you have not already done so, you can apply on-line at [www.fafsa.gov](http://www.fafsa.gov). PLUS loans cannot be processed without a completed FAFSA on file.
2. Complete and return this 2022–23 Federal Direct Parent PLUS Loan Worksheet. Complete and return this form to the Financial Aid Office in person or by faxing to 360-442-2379. Be sure to print clearly and answer all of the questions.
3. The total amount a parent can borrow is the estimated cost of attendance less the student's total financial aid.
4. Lower Columbia College participates exclusively in the Federal Direct Loan program. All PLUS Loan borrowers must complete a Master Promissory Note (MPN) for PLUS Loan with the Department of Education. Parent borrowers complete the Parent PLUS Loan MPN on-line at: [www.studentloans.gov](http://www.studentloans.gov).

### \*Student Eligibility

Before any Parent PLUS Loan funds can be disbursed, the student must be:

1. Enrolled in at least half-time (6 counting credit hours), and
2. Enrolled in an eligible degree-seeking program intending to graduate from LCC, and
3. Maintain satisfactory academic progress, see the Financial Aid Handbook available at [lowercolumbia.edu/finaid](http://lowercolumbia.edu/finaid)
