To be eligible to receive a waiver of tuition (up to 25% off the in-state tuition rate), you must meet all of the following:

- Submit a new application each academic year.
- Be a Washington domiciliary (as defined in [Revised Code of Washington - RCW 28B.15.013](#)), meaning you are a person who has a true, fixed, and permanent house and place of habitation in the State of Washington,
- Qualify as:
 - An active or reserve member of the United States military or naval forces, or a national guard member called to active duty, who served in active federal service, under either the Title 10 of Title 32 of the United States Code, in a war or conflict fought on foreign soil or in international waters or another location in support of those serving on foreign soil or in international waters
 - OR –
 - A military or naval veteran who did not serve on foreign soil or in international waters, but did support those that did. * *This category only includes only military or naval veterans. It does not include National Guard members.*
- If discharged from service, has received an Honorable discharge as indicated on the service member’s DD-214.
- Tuition is not entirely covered by another VA Education Benefit (Example: Chapter 33 with less than 100% eligibility).

NOTE: Under Washington State law, schools are only allowed to waive tuition for a maximum of 250 credits. Due to this rule many students choose to save their waiver for use at a 4-year college they will attend in the future.

All documents must be submitted to confirm eligibility prior to the waiver being applied to the student’s account.
