- 7. Attend a MANDATORY Running Start New Student Orientation for students and parents (more information will be sent after acceptance)
- 8. Pay your fees by the due date, get your student ID card, parking permit and books
- 9. Attend your classes, and check your LCC email, Running Start social media, CANVAS and REMIND text messages frequently for Running Start notifications and updates.
