- Katie Sully & Serina Graham, BFET Self-Care Station Request-Katie Sully is requesting \$1,000 to fund the startup costs for a self-care station filled with over-the-counter medications for underresourced students. These OTC medications would be available to help students with headaches, sanitary issues, and stomach aches who may not be able to afford medications. This station will be open to all students and will be located in the WorkFirst area and overseen by Mary Kate, Stephanie Bunn,

and Jodi Dahlke.. \$1,000 will cover the cost of the cart used to store the medication, initial supplies, and resource printing. After the initial startup cost, Katie Sully and Serina Graham will look for grants to continue funding or absorb the cost within their budget. Jake Roes asked when this station would be implemented and Katie hopes by June 9th. Lily James asked if it is legal to hand out medications, and Ms. Sully responded that several local colleges maintain similar stations. Paz Clearwater commented that we should at least check IDs before handing out supplies to ensure students are over 18. Tom Holtslander asked if there was a concern that students may abuse the station and Katie replied that this has not been the case at other schools. Tom Holtslander moved to approve the request and John Shaw seconded the motion. All were in favor, none were opposed, and none abstained. The motion passed unanimously. Katie will send charges for the station to Justin Ford so that they may be charged to the ASLCC budget.
