

# MINUTES OF THE REGULAR MEETING OF THE BOARD OF TRUSTEES COMMUNITY COLLEGE DISTRICT 13

April 20, 2005

#### 1. CALL TO ORDER AND DETERMINATION OF QUORUM

Chair, Mike Heuer, called the regular meeting of the District 13 Board of Trustees to order at 5:06 p.m., on Wednesday, April 20, 2005, in the Heritage Room in the Administration Building of Lower Columbia College. When the meeting was called to order, the following individuals were present; there was a quorum.

#### 5. COLLEGE INPUT

**5A. President's Report -** President McLaughlin reported that the legislature is wrapping up the session for this year. He is hopeful that funding from this session will include a COLA and enhancement package as well as \$20.5 million for construction of the new Fine Arts building. McDonalds is waiting for the necessary permits to move forward on construction at the Ocean Beach site. LCC is currently looking at replacement facilities for those folks who will be displaced when the old building is demolished.

The Nursing Department is pursuing "needs assessment" for entry level healthcare training, working with Peace Health, Kaiser and other healthcare providers in the community. The curriculum is designed to build a skill set for new employees wishing to enter health care professions as well as improving the skill set of incumbent workers.

Enrollment has been soft this year. Decline corresponds almost identically to the 200 FTE drop in sponsored (state paid) worker retraining students. Additionally, Basic Skills enrollment has declined due to leveraging tuition and fee charges, and two apprenticeship programs (non-union electrical and pipefitters) have moved from the area. The Cabinet has made adjustments in enrollment targets and marketing and hope to negotiate target adjustments with the State Board.

Dr. McLaughlin invited the members of the Board to meet Dr. Rod Paige, former Secretary of Education, May 11 at 6:30 p.m. in the LCC Student Center. This is part of our Student Government's annual Artist and Lecture Series. Dr. Paige is the principal sponsor of the "No Child Left Behind" law, and it will be quite an opportunity to hear him speak.

**5B. ASLCC Report** – Mary Harding reported for Jessica Grubb, ASLCC President. The students are sponsoring a fundraiser for Habitat for

Humanity, and they have also approved a new club – Spirit Club – to provide support at sporting events.

- **5D. WPEA Report** Ron Adkisson, WPEA President, reported that Public Employee Relations Commission (PERC) ruled on the appeal filed by the Washington Federation of State Employees.
- **5E. LCC Foundation** Merlene York reported that the Exceptional Faculty Committee has awarded \$43,750 worth of grant money for 2005. She also reported that the Foundation is reviewing 39 grant requests totaling \$156,908. The Family part of the campaign is almost complete with LCC boards (Trustees and Foundation) and employees pledging nearly \$200,000 in support. The next campaign phase is the Lead Gifts and which has already received a gift of \$100,000 in support of the science program.
- **5F.** Legislative/College Relations Janelle Runyon reported that they are working on implementing our new look. A college-wide marketing and enrollment plan is being prepared for implementation this summer, targeting several current academic programs and college services.

6A. Community Enrichment Monitoring Report - Wendy Hall, Director of Research, Planning and Assessment, introduced review team members Brendan Glaser and Jenny Smith. They reported on the critical role of the institution in promoting cultural awareness, as well as cultural appreciation in our community. The College has made concerted efforts to connect with the community through art, theater, music, and athletic events, as well as political and educational forums. They reported that LCC's athletic teams have been outstanding, as well as their academic achievement over the past five years. There have been a large number of students taking advantage of Tech Prep and attendance at drama performances is impressive. Areas that need improvement include enrollment in Community Ed and Senior Studies.

# 11A. Discussion Opportunity with Castle Rock School District Board and Administrators

Chair Heuer thanked Mr. Wilde and guests for giving the board an opportunity to share ideas between them and discuss ways that would help students prepare for college.
