

MINUTES OF THE REGULAR MEETING OF THE BOARD OF TRUSTEES COMMUNITY COLLEGE DISTRICT 13

June 20, 2007

1. CALL TO ORDER AND DETERMINATION OF QUORUM

5. COLLEGE INPUT

- **5A. President's Report** President McLaughlin reported that the College had hired Laura Brener as the new Vice President of Instruction to begin Aug. 1. He also reported:
 - That the College received a successful Math Transition Project grant sponsored by the Gates Foundation, which will allow for some of LCC's Math Faculty will meet with local K-12 teachers to try to better align the math curriculum and transitions;
 - The recent GED graduation had between 400-500 attendees;
 - The Main Building renovation project has started;
 - The labor strike has ended, which means our Fine Arts Center project is back on track;
 - Enrollment Vice President Mary Harding reported that spring enrollment was 1994 FTES, 3% lower than last spring. However, we didn't mean our annualized target enrollment; therefore, we will receive no growth enrollment, but we will also not be subject to a recovery year.

- **6A.** Institutional Excellence and Community Enrichment Monitoring Reports Wendy Hall, Kirc Roland, Therese Montoya, Steve Jones and Maggie Stuart presented highlights from these two reports.
 - Institutional Excellence Monitoring Report "Institutional excellence" is not an easy concept to define or measure. The key performance indicators for this outcome were carefully determined so they would not duplicate other aspects of excellence, such as transfer students' performance at universities and the estimated employment rate of professional/technical program completers. Indicators include student progress, relevance of programs, faculty/staff satisfaction and morale, external perceptions/satisfaction with LCC, student/graduate satisfaction with support services, and student persistence/performance. This report also presents data from the Student Services Retention program and the Running Start program. In addition, this report also presents the progress that has been made on the four strategic issues of the college's Strategic Plan.
 - Community Enrichment Monitoring Report Part of the mission of Lower Columbia College is to enhance the local culture of our service district. In an atmosphere of openness and diversity, the College strives to enrich the local community by hosting a variety of cultural events, visiting lecturers, and political and educational forums. Lower Columbia College also enriches the local community by educating our students to be productive and responsible citizens. The faculty, staff, and administration of Lower Columbia College recognize the critical role of the institution in promoting cultural awareness, as well as cultural appreciation, in our local community. To this end, College personnel have made concerted efforts to connect with the community through art, theater, music, and athletic events, as well as political and educational forums. Through the college's strategic planning process, the Executive Planning Committee identified two key performance indicators (KPIs) that are intended to measure the outcome of community enrichment. These include citizenship and cultural enrichment of students and community. Other data that are pertinent to the progress the College is making in this area have also been included, such as Tech Prep and the college's Career Center.
